Significant Events:

On the following dates/times Elsmere Bureau of Police officers handled the below incidents and seized the following drugs, money and weapons during the month.

November 1 , 2016:

On November 1, 2016, Ptlm. MacDowell conducted a pedestrian stop on four subjects crossing the railroad tracks in the 300 block of New Road. All four subjects were juveniles. Two juveniles were discovered to have warrants for Assault 2nd from New Castle County PD.

Upon further investigation, Ptlm. MacDowell was able to link the juveniles to a theft from a vehicle earlier in the evening. The subjects were charged with Burglary 3rd, Theft under 1500, Conspiracy 2nd, Loitering and Trespassing 3rd.

November 17 , 2016:

On Thursday, November 17, 2016, Elsmere Police Officers were approached by a town resident who asked to be escorted to his residence located in the 2700 block of Eastwood Drive in Elsmere, because of recent threats made against him because of a relationship he was currently having with a mutual person. Upon arriving at the residence the Elsmere Police located 44 year old Brian Glass from the 800 Block of Parkside Blvd Claymont DE in the rear of the residence . Mr. Glass was dressed in all black and armed with a 9MM handgun, an ASP baton, two (2) pairs of brass knuckles, five (5) knives, tactical gloves, tactical flashlights, and binoculars. Mr. Glass was taken into custody without incident and his vehicle was located nearby. Inside the vehicle, officers were able to observe an open book bag that contained rope and what appeared to be a black handgun. A search warrant was executed on the vehicle and located inside was a stun gun, a samurai sword, two (2) pellet/air soft guns, duct tape, rope, several more flash lights and knives along with binoculars and more rounds of ammunition.

Mr. Glass was charged with Stalking while in Possession of a Deadly Weapon, Terroristic Threatening, Loitering (Night Prowling), Criminal Trespass 3rd, Degree, Possession of a Weapon During the Commission of a Felony x 6, Possession of a Firearm During the Commission of a Felony, Carrying a Concealed Deadly Weapon x 6. Mr. Glass was arraigned on his charges and his bail was set at \$79,002 secured. Mr. Glass was turned over to the Department of Corrections in lieu of bail.

November 26 , 2016:

On November 26, 2016, PFC. West was flagged down in the area of Sanders Road @ Rigdon Road at approximately 0515 hours. The citizen advised PFC. West that he observed two unknown black males inside of his vehicle and a third male stand on the street acting as a look out. PFC. West conducted a property check of the area of located Raymond Penn hiding in the stairwell behind Unit Block of Sanders Road. Raymond was detained and was found to be sitting on a pink purse, American Express credit card, medical card and two prescription bottles. Raymond was also found to have assorted

change and a lottery ticket on his person which were the items taken from the original citizens vehicle.

All items were returned to the owners.

PFC West was able to clear three different vehicle break-ins based on the property. The thefts occurred from two vehicles on Rigdon Road and Taft Avenue.

Raymond was charged with Burglary 3rd (3X), Theft under \$1500 (3X), Conspiracy, Trespassing and Loitering. He received \$5,100.00 unsecured bail. Raymond also had 3 active capiases of which one was set as \$1,000.00 secured and he was transported to Howard Young Correctional Institute after not being able to post bail.
