Town Manager John Giles stated that the Mayor and Council must annually set the Tax Rate, in addition they have passed a resolution that says that they will consider raising taxes by COLA each year. This year that would mean a .24% increase which is equivalent to \$1.05 per household.

Presentation, Discussion and Public Hearing concerning the FY 2016-2017 Proposed Operating, Revenue and Capital Budgets.

PUBLIC SAFETY DEPARTMENT

Chief Laura Giles stated that she has a number of changes to make in her department based on the resignation of an officer within the Department. She would like the Mayor and Council to consider transferring officers into the State of Delaware Pension Plan once they have been with the Town for 5 years. She made the following Line Item Changes from the budget submitted to the Mayor and Council on May 16, 2016:

Mayor Burg asked why there was a need to decrease the Code Enforcement Violations Line Item.

PARKS AND RECREATION

At this time there was a lengthy discussion regarding Civic Affairs and which events could potentially be eliminated.

ACTION: A motion was made by Councilman Zielinski to cut the movies in the parks budget to \$2,500.00. The motion was seconded by Councilman Jaremchuk.

- Shredding Event Reduced to \$0.00 Cut the event.
- Household Hazardous Waste Collection Reduced to \$0.00 Cut the event.
- Bicycle Rodeo Reduced to \$0.00 Cut the event.
- Annual Town Wide Clean-up Day Reduced to \$0.00 Cut the event.

ACTION: A motion was made by Councilman Jaremchuk to remove the Town Wide Clean-up Day for one year and to re-evaluate during the next budget. The motion was seconded by Councilman Zielinski.

VOTE: 7-0 All-in-favor Motion carried

Town Manager John Giles stated that the Veterans Day Celebration is planned to be a one-time event that he intends to cut this event next year.

ACTION: A motion was made by Councilman Jaremchuk to approve the Parks and Recreation Departments Budget as amended. The motion was seconded by Councilwoman Personti.

PUBLIC WORKS DEPARTMENT

The following line item changes were proposed:

Town Manager John Giles stated that based on the actions taken by the Mayor and Council by eliminating the Capital Improvement Budget the Town could face significant fines for violating NPDES and that regardless of whether they agree with the costs, it is a mandate that we must comply with.

ACTION: A motion was made by Councilman Jaremchuk to approve the Capital Improvement Budget as proposed. The motion was seconded by Mayor Burg.

LONG TERM PLANNING

Town Manager John Giles stated that at this point the Revenues exceed the proposed Expenses by \$6,298.00 and that the Town is required to pass a balanced budget.

ACTION: A motion was made by Councilwoman Personti to increase the Contingency Fund Allocation to \$13,298.00. The motion was seconded by Mayor Burg.

Councilman Pfirrmann stated that there was a lot of money taken out of the Civic Affairs budget and he would like the Council to consider restoring some of that out of the \$6,998.00 Surplus.

Councilwoman Personti withdrew her motion for additional discussion.

Councilwoman Personti asked Town Manager John Giles if he was given money to put back in his budget somewhere, where would it be?

Town Manager John Giles stated that Maintenance to Equipment in the Public Works Department would be his top priority for restoration. He stated that he would like to see \$3,000.00 to Maintenance Equipment in Public Works and the remaining \$3,998.00 to Contingency he would be happy.

ACTION: A motion was made by Councilwoman Personti to increase the Public Works Maintenance Equipment to \$8,000.00 and Increase Long Term Planning Contingency Allocation to \$10,298.00. The motion was seconded by Councilman Zielinski.

At this time there was a brief discussion regarding the Council's decision to not increase the property tax rate during the current year.

The Town Manager is requesting the Mayor and Council amend a Job Description within the approved Wage Compensation Plan.

Town Manager John Giles stated that he would like the Mayor and Council to consider amending the Job Description for the Administrative Assistant to the Town Manager. The changes proposed are to change the paygrade from a paygrade 14 to a paygrade 18, as well as to remove a line stating "Perform a broad range of Supervisory Responsibilities over others" and inserted "Effectively communicates the Town Managers wishes to other employees in the absence of the Town Manager."

Town Manager John Giles further stated that the person he intends to promote has been with the Town for a long time and in their current position and completing the duties described in this exact Job Description for 5 years and just has not had the pay or title for it.

ACTION: A motion was made by Councilman Jaremchuk to change amend the job description for the Administrative Assistant to the Town Manager as proposed. The motion was seconded by Mayor Burg.

VOTE: 7-0 All-in-favor Motion carried

Town Manager John Giles stated that he will be proposing an additional charter change in the near future that changes the Charter regarding the Finance Committee. The current charter designates the Finance Committee as the Audit Committee which he has no problem with, however, the Charter also states that the Finance Committee will solicit RFP's and select the auditor which he believes should fall solely on the shoulders of the Mayor and Council. It also states that they shall meet with the Auditor and answer any questions they may have, which is handled by the Finance Department as part of Day to Day operations.
