 - a. Authorization of the amount of money which needs to be transferred from DELGRIP to First State Trust to cover expenses through December of 2019.

Town Manager John Giles stated that a spreadsheet was provided at the beginning of the meeting by the Finance Director that is proposing a transfer from DELGRIP to First State Trust in the amount of \$149,753.00 and from the Town's Long Term Planning in the amount of \$35,753.00 to cover the remaining expenses totaling \$185,353.00 through December 2019.

ACTION: A motion was made by Councilman Brian Hurst to transfer \$149,753.00 from DELGRIP and \$35,753.00 from the Town's Long-Term Planning Line to First State Trust to cover the total costs of \$185,353.00 of the remaining expenses through December 2019. The motion was seconded by Mayor Eric Scott Thompson.
